Terms and Conditions

- 1) Information on prizes and how to participate forms part of these terms and conditions.
- 2) The Promoter is Moonee Valley Racing Club Inc (ABN 45 806 588 917) of Gate 1, McPherson Street, Moonee Ponds VIC 3039.
- 3) Entry is only open to guests that dine in the MVRC Dining Boxes on 3rd, 10th, 17th & 24th February 2012. Employees, directors and other representatives of the Promoter and organisations involved in sponsoring or conducting this promotion (and any individuals so involved) are ineligible, as are members of their immediate families and households.
- 4) The Prize is non-transferable, non-exchangeable.
- 5) The promotion commences at 6.15pm on 3rd February and concludes at 10.15pm on 24th February 2012.
- 6) All guests that book dining in the Dining Boxes for the month of February will be asked to enter a business card draw. The draw will close at 7.20pm each night. A guest will be drawn for races 3 to 8, the guest then gets to draw out a number of a horse running in the next race. If the horse wins, they win \$250.
